*Any child picked up after 6pm will incur a late charge of \$1/minute.

Charges will be billed monthly via FACTS and have been capped as follows:

Before Care ONLY:

\$80/student per month

Before and Aftercare COMBINED

4+	After reaching the cap for 3 children, any additional child may attend at no/charge.

Normally, the Aftercare program will operate from the time school is dismissed until 6pm. Occasionally, the program will close at the early dismissal time due to holiday schedules.

Students will be checked in to Before and Aftercare each day by a staff member via FACTS.

ALL authorized caregivers are asked to report to the <u>cafeteria</u> for pickup. If your child is at another activity location (club/playground, etc.), they will be retrieved by a staff member and brought to the cafeteria to be checked-out. Please be aware that we are unable to release a child to anyone not on the authorization list provided by the parent/guardian via FACTS. Proper identification must be produced to retrieve your child.

We are happy to be able to provide nut-free snacks for purchase during Aftercare. If you do <u>NOT</u> want your child to be able to purchase snack during Aftercare, please email me at mastrogiovanni@stmm.net.
